

Sri Lankan Education Data Management Revolution Begins...

Intervention of KOICA and KEDI

Korea International Cooperation Agency (KOICA) and Korean Educational Development Institute (KEDI) are striving to carry out development cooperation programmes with the Ministry of Education (MoE), Sri Lanka under the mission of promoting the sustainability of educational data management.

Challenging situation

The availability of updated, accurate, timely data is the paramount factor for effective decision making and evidence-based policy making once such data are analyzed for particular purposes in the Sri Lankan education sector.

The MoE, Sri Lanka was facing a difficulty in collection of data due to the absence of a dedicated person at the point of data collection resulting in prevalence of invalid data in consequence of delays due to the refining and validation.

First ODA project with the KOICA and KEDI

With the first Official Development Assistance (ODA) project with the KOICA and KEDI initiated in 2020, bridged the gap between what was lacking in the data management in Sri Lankan education system and what was to be done initially to strengthen the process for a sustainable data management development plan. This first ODA is a result of the 'Asian Cooperation Educational Statistics Capacity Development' project conducted by KEDI from 2017 to 2019 as a consultation project for Mongolia, Vietnam and Sri Lanka. The action plan developed as the output of the ODA project which was implemented in Sri Lanka by nominating Data Officers in general educational institutes island wide joining hands with the provincial educational force, from the already available academic and non-academic staff in the education sector. This nomination was done by the school principals and the officials in charge of respective educational organizations following the clearly stated guidelines released by the Data Management Branch and Information System Development Unit of the Ministry of Education in 2022.

The distribution of Data Managers and Data Officers are as follows;

The nominated Data Officers engage in the educational statistical related affairs successfully at present such as data collection for annual school census conducted by the Department of Census and Statistics, data entry process for the Mid-Day Meal Programme conducted by The World Food Programme (WFP), etc.

This has become a turning point in the school data management endeavors and moving forward to a blessed future with extended activities to get the technical and financial support from the experts in KOICA and KEDI.

Training Data Officers

The nominated Data Officers and Data Managers are scheduled to provide an online, self-paced training with the launch of the Data Management LMS platform with well-designed seven modules in both Sinhala and Tamil medium including 76 learning videos covering around 4-hour learning sessions. In successful completion of all online training modules which are specially designed for enhancing the capacities of data management, the Data Officers will be rewarded with an e-certificate which can be verified internationally. In this manner, the sustainability of the training of Data Officers is confirmed.
